Seller warrants the product sold under Seller's trademark to be free from defects in materials and workmanship for a period of 12 months from date of shipment. If within such period any such equipment or parts shall be proved to Seller's satisfaction to be defective, such equipment or parts shall be repaired or replaced at Seller's option. Seller's obligation hereunder shall be limited to such repair and replacement and shall be conditioned upon Seller's receiving written notice of any alleged defect within 10 days after its discovery and, at Seller's option, return of such equipment or parts to Seller, f.o.b. its factory at Tulsa, Oklahoma. This warranty shall not apply to equipment or parts which shall have been repaired or altered by others than Seller, or which shall have been subject to negligence, accident, damage by circumstances beyond Seller's control, or improper operation, maintenance or storage, or to other than normal use or service.

Shipment is f.o.b. factory. Acceptance by the carrier constitutes delivery by the Company and purchaser must file any claims for damage or loss in transit against the carrier. Any claim should cover concealed damage as well as visible damage. Upon request, the Company will supply purchasers with shipping papers necessary to support such claims.

Material should not be returned until authorized by the Company.
